

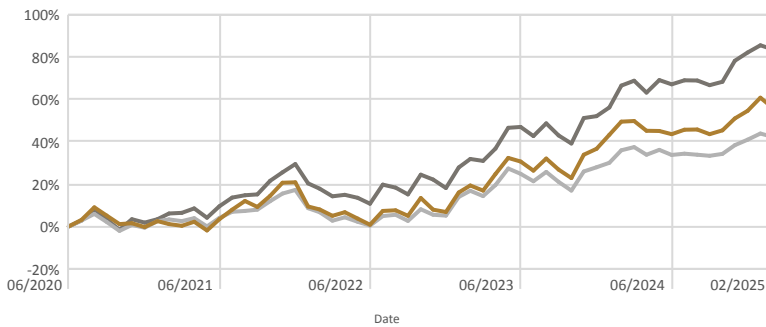
INVESTMENT OBJECTIVE

The Vunani BCI Global Macro Fund aims to provide investors with a high long-term total return. The objective is to deliver above average benchmark returns over the longer term through investing in a range of high quality companies that exhibit above average earnings growth relative to their sector peers and overall market

INVESTMENT POLICY

The portfolio shall have the maximum flexibility to vary assets between the various markets, asset classes and countries to reflect the changing economic and market conditions, subject to a minimum offshore exposure of 80% of the portfolio's value. The portfolio's investment universe consists of equity securities, preference shares, property shares and property related securities, interest bearing instruments and non-equity securities as well as assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments

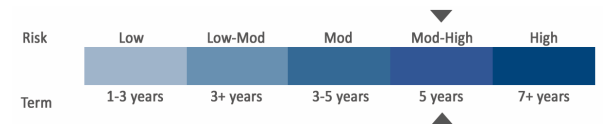

Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
