

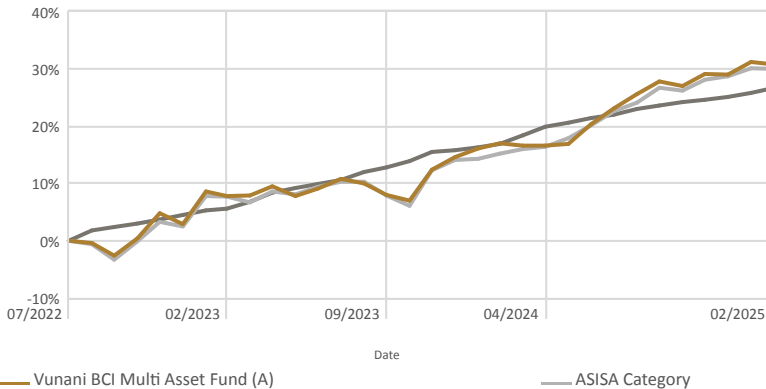
INVESTMENT OBJECTIVE

The Vunani BCI Multi Asset Fund aims to deliver a moderate long-term total return by investing across a broad range of asset classes. The Fund also aims to protect capital over rolling 12 month periods.

INVESTMENT POLICY

The fund aims to deliver a moderate long-term total return by investing across a broad range of asset classes. The manager will seek to capture opportunities by actively managing the portfolio's asset allocation and instrument selection. The portfolio maintains a moderate risk profile and its maximum equity exposure is 60% of its net asset value. The investments to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities as well as participatory interests or any other form of participation in similar portfolios. The portfolio may from time to time invest in listed and unlisted financial instruments.

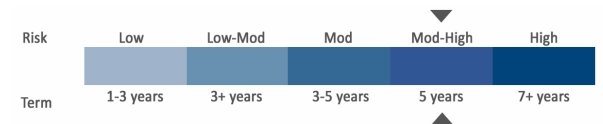

RISK PROFILE



Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a medium risk portfolio, but less than a high-risk portfolio. The probability of losses is higher than that of a medium risk portfolio, but less than a high-risk portfolio and the expected potential long-term investment returns could therefore be higher than a medium risk portfolio.
