


INVESTMENT OBJECTIVE

The Vunani BCI Bond Fund aims to outperform the FTSE JSE All Bond Index (ALBI) with concomitant levels of risk, mainly through yield enhancement. The portfolio invests predominantly in domestic bonds.

INVESTMENT POLICY

Investments to be included in the portfolio will comprise of assets in liquid form and a combination of bonds and interest bearing securities, including loan stock, notes, debentures, preference shares, money market instruments, corporate debt, convertible equities and other non-equity securities. The portfolio may also invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.




RISK PROFILE
