INVESTMENT OBJECTIVE

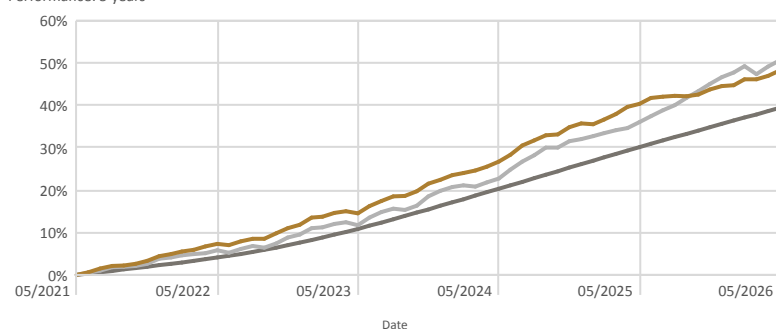
The Vunani BCI Enhanced Income Fund is an income generating portfolio with the objective to achieve a high level of sustainable income and stability of capital invested.

INVESTMENT POLICY

In order to achieve its objective, the portfolio may invest in a combination of cash and cash equivalents, equity securities including preference shares, convertible equities and non-equity securities, including interest bearing instruments, and investments in property securities. The portfolio may hold participatory interests in a CIS portfolio or other approved collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. The portfolio's equity exposure shall not exceed 10% of the portfolio's net asset value. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act, and the Regulations thereto, as amended from time to time, in order to achieve the portfolio's investment objective.

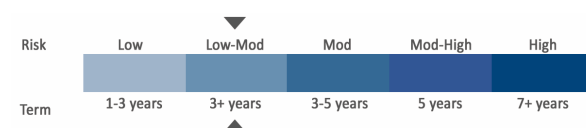

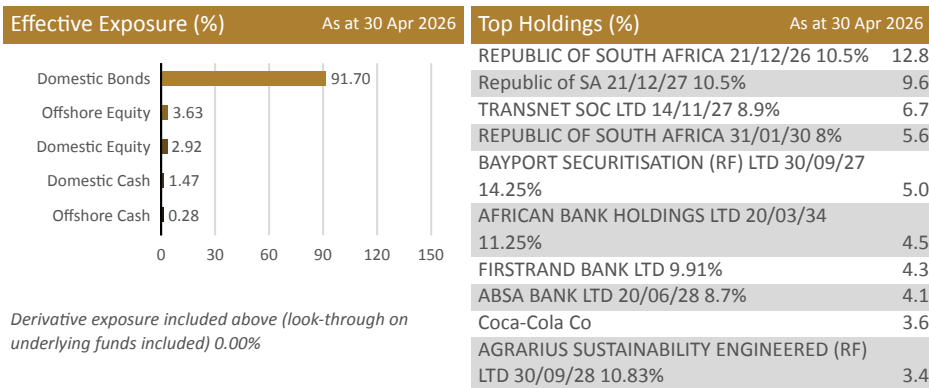
Low Risk
